## From The Office Of The Mayor.....

Summer is here and with it comes many activities for young and old alike. Please read the Recreation Center brochure regarding the many activities available this summer. City Hall and the various commissions will be hosting several events of interest to everyone.

Wednesday, May 18, is a Food Truck event at the City Hall parking lot which will benefit "Responder Rescue"; an organization providing assistance to any area first responders who have been injured, become ill or suffered a traumatic situation after all other resources have been exhausted. Please plan to attend this event, from 5 to 8 PM.

My congratulations to those elected or re-elected to the Board of Aldermen this past April. See pages 6 and 7 for details. I also want to thank those who voted for passage of Proposition B; continuing the sales tax of motor vehicles purchased from out of state and registered here. The failure of this Proposition would have cost the City about \$137,000 next year.

I need to remind everyone to trim and cut your grass.

If your grass exceeds 8" you will be sent a letter asking you to cut your lawn or a citation will be issued. It is far cheaper to cut your grass than to pay a fine for failure to comply with the ordinance. Be considerate of your neighbors and the neighborhood. Help keep our neighborhoods clean of trash and debris; please don't litter.

I encourage everyone to get involved with our City: come to meetings, volunteer to help during events, or join our Image and Beautification Commission and help make our City beautiful. Openings are also available on the Youth Commission. I hear from people who "talk the talk, but don't walk the walk". This is your chance to get involved and help your City where the need is greatest.

Our Police Department will, again, be hosting a summer Youth Program during the month of June. This year will be a little different than last year; please read more on page 3.

## From The Office Of The Chief.....



Chief Jeremy Ihler has issued the following Certificates of Merit and Letters of Commendations.

**Officer Aaron Neff and Officer Travis Dickens** received the Certificate of Merit. Officer Neff was on

leave with the National Guard so he was not present to receive his award. The award stated the following:

For their professionalism, performance, and active quality law enforcement efforts. On October 19, 2015, Officer Dickens received a police call for service in the 1200 block of Chambers in reference to adults who displayed and pointed a firearm at juveniles. Upon arrival, Officer Dickens investigated the incident and located the adults based on the description provided by the juveniles. Through conversation and a consensual search, a firearm was located and seized. The investigation resulted in the arrests of both adults for unlawful use of a weapon and the issuance of warrants by the St. Louis County Prosecuting Attorney's Office. Officer Dickens' com-

mitment to quality law enforcement has had a positive impact on crime in the Bellefontaine Neighbors community.

**Officer David Schack and Officer Roland Shreves** received the Letter of Commendation for Life Saving. Gibson school nurse Nicole Stockmann received the Citizen Citation Award for Life Saving. Nicole Stockmann was not available to receive her award. The award stated the

following:

For exceptional performance of saving a person's life. On December 14, 2015, Officer Schack was outside at the Gibson Elementary school when he was alerted by a motorist to a person in distress. The man was cyanotic, barely breathing, and unable to communicate with Officer Schack. Gibson Elementary School Nurse Nicole Stockmann was present, assessed the man's medical condition, and made available a defibrillator. Along with Officer Shreves, all three provided medical attention through CPR techniques and the application of the defibrillator when the man became unresponsive. The man was transported to the hospital and survived his tragedy due to the life saving actions of the first-responders.

Warm weather brings people out of their homes and into our parks and open places. St. Louis County reminds residents bordering County Parks to report any disturbances or violations you see or hear.

For over 50 years the St. Louis County Park Rangers have provided public safety for visitors to the parks in our system. The basic duties of a Ranger revolve around the three main goals of our division: Public



Relations, Programming, and Protection.

Rangers can issue citations or summons for violations and are trained in arrest techniques, firearms, search and seizure and defensive tactics.

## Senior / Disabled Transportation Service



The City of BN took possession of our new bus that will allow us to provide transportation service to the Seniors and Disabled in the city. The new bus had been approved in 2012, but was on back order because of financial limitations.

The service takes residents to local stores, activities at the Recreation Center, beauty shops, stores, pharmacies, library and doctor appointments along the 270 corridor as far as DePaul Health Center on St. Charles Rock Road. The service is free, but residents must purchase an ID card for \$5 per year.

If you are not registered to vote, please stop by the City Hall, any public school, license office or library and register. You must be registered by July 6 to vote in the August election.

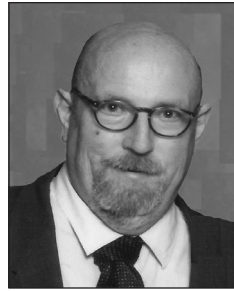

## Dog & Cat Clinic

City of BN ordinances require dogs and cats have current rabies tags. The city provides an opportunity to get vaccinations and tags at reduced costs at the Annual Dog & Cat Vaccination Clinic.

The attending Veterinarian is Dr. Dan Wendt, DVM, who owns and operates the Ferguson Animal Clinic at 843 Airport Road. You can get a discount by showing a spay or neuter certificate.

City ordinances also require that dogs and cats have a City of BN license. The cost of the license is \$2 and can be purchased at the clinic when you get the shots or at City Hall during regular hours by showing proof of rabies vaccination.

When pets are vaccinated, they get rabies tags. If pets are found by Animal Control officers, tag numbers or microchip numbers are immediately checked by their computers to reunite lost pets with their owners. Pets can't tell authorities where they live - and tags serve as your pet's "Free Phone Call Home!"

(a) No person shall knowingly enter unlawfully or knowingly remain unlawfully in any building or inhabitable structure or upon real property in the city.

With summer coming and kids going to friend's houses and other places, it is time to remind them not to trespass.

In the legal sense, trespassing means you are physically on another person's property without being invited there. This can occur in many dif-



ferent types of situations. You could be taking a shortcut across a field ignoring signs on a fence saying "No trespassing." If so, you'd be breaking the law.

A property owner has the right to have anyone caught on their property who isn't invited to be arrested and charged with criminal trespassing. This does not apply to people who have the legal right to be on the property such as mailmen or meter readers.

"No Trespassing" signs are recommended.

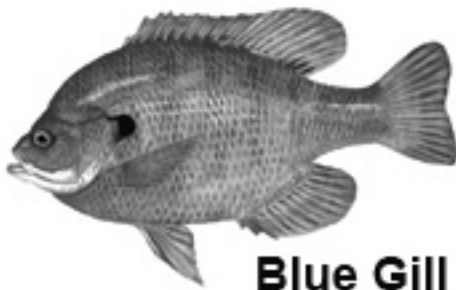

# Parent's Guide To Social Networking Sites

Facebook, Snap Chat, Instagram and Twitter. These are examples of social networking sites. Such sites allow people to make new friends, send messages, share photos, etc.

## Can Social Networking Sites be Harmful?

Social Networking sites are a great way to catch up with old friends and meet new, interesting people. But can they be dangerous? Here are a few recent cases relating to social networking sites:

- Cases have been reported in the UK and US of sexual predators posing as teenagers and trying to solicit young children and teenagers.
- A mother was happy that her eleven-year-old was using the computer often. However, she was horrified to see her daughter posting inappropriate photos of her profile on a popular social networking site.
- A teenager was shocked when the police came to his house one day. Apparently, someone had sent obscene messages to his acquaintance using his account and password.

**Privacy and Safety:** It is important that you recognize safe, good quality sites where your child's personal information cannot be misused. Explain the possible risks of using a social networking site. Encourage your child to:

- Never reveal addresses, phone numbers, addresses, passwords or any bit of personal information. Never add a stranger as a friend or share personal information with them.
- Avoid meeting someone who is just an online contact in person. If your child is planning to meet someone they met on line, ensure that it happens under your supervision. Posting one's name, photos and information make it easy for someone to locate the person.

- Never click any links that come from strangers in messages and e-mails. More often, such links turn out to be promotions of websites, especially pornography.

**Netiquette:** Just as in the real world, we need to maintain a basic set of manners on the online world. Here are some tips you should share with your children:

- Never use abusive, sexually explicit or inappropriate language on an on-line forum, e-mail message or profile. Denigrating other religions, people and races should be avoided.
- Never post inappropriate images that show nudity, personal information, blood and violence in albums or as a profile picture.
- Never use social networking sites to spread rumors, chain mails, and unconfirmed stories that can potentially damage someone's life or career.

## What can you do?

- Encourage your child to speak openly about their on-line experiences and problems.
- Install software that can control access to objectionable sites, especially if your child is under age 13. Net Nanny is an example.
- Encourage your child to share their profile link with you. Remember many children have multiple accounts on different social networking websites.
- Monitor their profiles regularly. At the same time, respect their privacy. For example do not send them messages that their friends can read. Your child may find it embarrassing.

Do not force your child to avoid such sites. Your child will soon find other ways to access these sites. Social networking websites have their advantages and drawbacks. What is important is to help them think critically for themselves.

## Mosquito Control

The City of BN contracts with St. Louis County for mosquito control. Spraying is done on Mondays, but you will not see them in your neighborhood every Monday.

Mosquitoes can develop in any standing water that is present for more than five days. To reduce the mosquito population around your home and property, eliminate all standing water and debris. Report standing water to the

City Hall at 867-0076. Eliminating standing water is the most effective way to control mosquitoes. Mosquitoes like to rest in vegetation or grass clippings, so keep your grass cut and get rid of clippings.

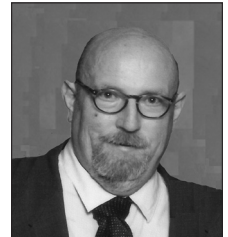
