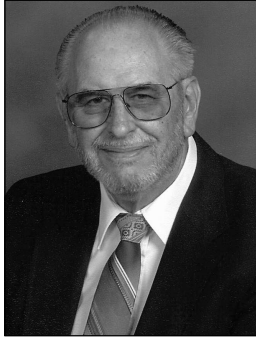

1968. Frank has a Bachelor of Science Degree in Architectural Engineering from the University of Illinois. When he was appointed, he was still on active in the United States Army Reserves after having served in the Korean conflict.

Frank served under Mayor Ray Zelinski, Mayor Joe Berger and Mayor Marty Rudloff. Former Mayor Rudloff was on hand to thank Frank for his dedicated service. Frank was presented a framed tribute reflecting his appointment and a proclamation from Mayor Robert J. Doerr commending him for his service.



## Mathews - Dickey Boys' & Girls' Club

The Surrey Lane Athletic Association served the youth of the City of BN and surrounding areas well for the past 50 years at Bob Russell Park on St. Cyr and Bellefontaine Road. During recent years, the Association has had financial problems and finally, this year, they were forced to fold. Because of a deed restriction, the park had to be passed on to a not-for-profit organization and used as a children's sports park. Trustees made the decision to donate the park to the Mathews - Dickey Boys' & Girls' Club, located at 4245 Kingshighway Boulevard in St. Louis.

Mathews - Dickey Boys' & Girls' Club announced June 26, live on KMOX radio, the donation of Bob Russell Park, 1101 St. Cyr Road, located in The City of BN, to their club. Mathews - Dickey Boys' & Girls' Club annual "Jack Buck Celebrity Night With the Stars and Tony LaRusso," was held at the Missouri Athletic Club with over 300 in attendance, celebrating the announcement.

they may have never been able to before. Mayor Doerr said, "Bringing the Mathews - Dickey Boys' & Girls' Club to the youth of North County, rather than them having to go to Mathews - Dickey at their present location is our goal. We are very excited that Mr. Mathews has accepted Mr. Russell's plan to aide in the growth and future expansion of his club".

The legal transfer of the park has begun and should be finalized in the next few weeks. As soon as the deed is transferred, the fields will receive a complete overhaul. Mr. Mathews is exploring possible future projects that will make this one of the best sports parks in St. Louis County.

Mayor Rudloff's award was based on the following Press release from North County, Inc: For the past three decades Marty Rudloff has given of his time and expertise to the City of Bellefontaine Neighbors. He started his public service on the Youth Commission in 1980 and was elected Alderman in 1981. In 1991, he was elected Mayor. Under his leadership the City was the first to respond to the state program during

the Flood of 1993, started the Family Festival, and hosted the Vietnam Veterans Moving Wall. Several new businesses came to The City of BN, including White Castle and the busiest QuikTrip in the region. He helped start a senior transportation service, updated and added recreation facilities, and a 5.5 million dollar bond issue was passed for street repairs. He is a member of the Holy Name of Jesus Catholic Church's Parish Men's Club, the Knights of Columbus, Santa Cruz Council 1215.

Senator Tim Green was also recognized by NCI for his efforts: For the past 22 years Senator Timothy Green has served the citizens of North County as a state representative from 1989 - 2002, and as the state senator for District 13 since 2004. Green dedicated his service to protecting

working families and the most vulnerable of our citizens. His accomplishments include securing funding to keep the Bellefontaine Habilitation Center open. On behalf of Missouri Veterans, he secured funding

to help build and staff a new wing at the Veteran's Home for dementia and Alzheimer's patients. As a member of the SSM DePaul Health Center Community Advisory Board, Green recognized the importance of maintaining trauma services in North County and in partnership with DePaul and other community leaders, found alternative funding and options to keep trauma services available. Green is a member of IBEW Local #1, the Greater North County Chamber of Commerce, DePaul Health Center's Community Advisory Board, Spanish Lake Community Association, and is the president of the Missouri State Building & Construction Trades Council (AFL-CIO).

## Sen. Timothy Green Works To Protect Missouri's Veterans' Homes

With the recent national uncertainty about raising the federal debt ceiling many people are concerned about Missouri's state budget outlook and the loss of Federal stimulus dollars in the coming fiscal year creating funding gaps for Missouri Veterans' Homes. An article in the St. Louis Post Dispatch highlighted that if nothing changes the veterans' homes will run out of money in July, 2013.

Representing one of our Veterans' Homes in Bellefontaine Neighbors, I am committed to working with my legislative colleagues to pass a balanced state budget for the next fiscal year.

In addition to securing the state funding to continue operation of the homes, progress must be made on reducing and eliminating a waiting list of 1,600. Providing for staff increases that eliminate the number of vacant beds; ensuring Veterans receive state and federal benefits they have earned; and maintaining and repairing the Veterans' Homes are priorities.

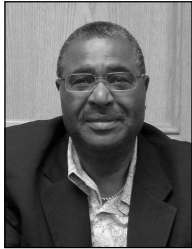
Veterans should not wait to be cared for in their last years. We counted on them to protect us in times of crisis and war; we'd better ensure that they get the services they need now.

# St. Louis County Communications Bureau

Public Safety Supervisor Chris Trittler and Sergeant Eric Holtz from the St. Louis County Police Department were guest speakers at the Neighborhood Watch meeting on May 4, 2011. They were there to inform residents how the Communications Bureau operates.

In 2010, St. Louis County handled 429,954 Information Calls and 387,067 Emergency Calls, a total of 817,021 calls. St. Louis County has 70 dispatchers, 16 per shift. The communications division follows more than 400 police officers at a time and answers 911 calls in an average of 2 seconds.

The Communications Bureau encourages residents to call at the first sign of an emergency or to report suspicious persons, vehicles or activities. The sooner you call, the sooner they can get help to your location.

When you call 911 from a land line, the police know the number you are calling from and your address. You can ask to remain anonymous or be contacted by phone only, but remember, your calls are important.

When you call the dispatch number, 889-2341 from a land line to report a problem, your name, address and phone number are not known. You can report suspicious persons, vehicles and activities anonymously.

Currently, newer cell phones register general coordinates on the dispatch screen, but pinning the exact location is not possible. Older cell phones cannot be traced at all, except for the number. Thanks to the bond Issue passed in 2010, cell phone location information will be greatly improved by 2014.

Another big improvement will be the Tornado Warning System. The county had 212 tornado sirens. The new system will have 184 more powerful, more strategically placed sirens.

Dispatchers go through vigorous training before they are assigned to stations. Communication employees are 'trainees' for 12 to 20 weeks, working with qualified, experienced dispatchers until they are ready to go on service alone.

Dispatchers attend monthly training to prepare them for any situation. Dispatchers may ask questions that you do not think apply, but they are trained to assess the situation and make the best call in the interest of the caller, police officer or first responder that will answer the call. Please answer their questions then offer additional information.

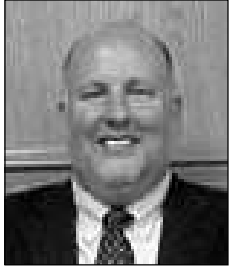
## William R. Gebhart, Sr.

## Free ENERGY STAR Light Bulbs

We have a unique opportunity for our residents to receive **free** ENERGY STAR compact fluorescent light bulbs from Ameren Missouri.

Ameren is giving The City of BN as many as 6,000 of these bulbs. The bulbs are available in 60, 75 and 100 watts.

The compact fluorescent bulbs will be available in September on a first come first serve basis. All you have to do is come to City Hall, show proof of residency and sign for them. There is a limit of 3 per household. Once they are gone, the program ends. We will also have them available at the town hall meeting if the supply lasts.



Earning the ENERGY STAR means products meet strict energy efficiency guidelines set by the US Environmental Protection Agency. Saving energy helps you save money on utility bills and protect the environment by reducing greenhouse gas emissions.

An ENERGY STAR qualified light bulb:

- Can save more than \$40 in electricity costs over its lifetime.
- Uses about 75% less energy than standard incandescent bulbs and lasts at least 6 times longer.
- Produces about 75% less heat, so it's safer to operate and can cut energy costs associated with home cooling.

Compact fluorescent bulbs should be recycled properly. They can be recycled at most major hardware stores, including Home Depot, Ace and True Value.

In August 2010 the voters of the Riverview Fire Protection District ((RFPD) approved a \$3,000,000.00 bond issue of which a portion will be used to replace the fire districts house number 2 located at 9207 Bellefontaine Road.

The Architectural Company chosen to assist with this project is Archimages with Roy Mangan and Jeff Williams as the architects. The design process took about five (5) months and upon completion of the building design the project was put out to bid for a General Contractor.

After review of the submitted bid proposals and interviews with three of the contractors the Fire District Board of Directors chose United Construction ENT. Co. as the General Contractor. Mr. Dino Pappas has been assigned as the Project Manager for United Construction Co. and Tim Smalling has been assigned as the project superintendent. The new engine house will be built on the same site. This will be the first new engine house for the fire district since 1958.
