Major Willis discussed GPS being added to the police vehicles so that data can be provided when citizens make complaints of no officer patrols.

Chief Goldstein from North County Fire briefly described calls from the Bellefontaine Neighbors area and will provide monthly or quarterly reports for trends.

James Thomas – Requested No Parking Signs at the intersection of Comet & Dwight because a resident is parking his commercial vehicles blocking drivers' visual. Bryant Nelson will meet with the city engineer to see about having the signs installed at the intersection.

Clearance Wilson – Discussed the need to speed patrol on St. Cyr. Major Willis provided information on the police efforts to curb speeding. BFN has a no-chase policy for minor traffic violations and cannot pursue a fleeing vehicle just for speeding.

Another resident concern was to see more programs offered for our youth. Felicia Bishop provided a list of programs that the Director of Parks and Rec is implementing and that residents should visit the Rec Center for further details.
